Please read these Terms and of Use carefully. By clicking "Accept", scheduling an appointment or submitting patient information, creating an account with Walmart Health, or using the Walmart Health Sites, you agree to these Terms of Use.

IMPORTANT: THE TERMS OF USE CONTAIN A MANDATORY ARBITRATION PROVISION IN SECTION 15 BELOW THAT REQUIRES THE USE OF ARBITRATION ON AN INDIVIDUAL BASIS TO RESOLVE DISPUTES. 1. Introduction

Welcome to the Walmart Health website. These Terms of Use govern your access to and use of all Walmart Health Sites. By using the Walmart Health Sites, you affirm that you are of legal age to enter into these Terms of Use, or, if you are not, that you have obtained a parent or guardian's consent to enter into these Terms of Use. If you violate or do not agree to these Terms of Use, then you access to and use of the Walmart Health Sites is unauthorized.

DEFINED TERMS: In these Terms of Use:

- When we say "**Walmart Health**" we mean MC Health MSO LLC ("**MSO**"), on behalf of itself and the professional entities to which it provides management services, which includes but is not limited to, MC Medical LLC, MC Dental LLC, and MC Brown Optometry LLC. We are also referring to Walmart Health when we say "**we**", "**us**" and "**our**". But when we say "**Walmart Health Entities**", we mean Walmart Health and its affiliates; its and their suppliers, vendors, contractors, and licensors; and its and their directors, officers, employees, and agents.

- When we say “**Walmart Health Sites**”, we mean www.walmarthealth.com and all related functionality, services, and Content offered by or for Walmart Health on or through www.walmarthealth.com or the systems, servers, and networks used to make the Walmart Health Sites available. The Walmart Health Sites include the Portal.
- When we say “**you**” or “**your**” we mean any user or patient (like you!) using the Walmart Health Sites.
- When we say “**Terms of Use**” we mean these Terms of Use (and any updates by Walmart Health to these Terms of Use).
- A few other key terms used in these Terms of Use:
 - When we say “**Content**” we mean information, descriptions about the services provided by Walmart Health, reviews, comments, messages, reviews, communications, feedback, submissions, suggestions, questions, and other information, data, content, and materials (including page headers, images, text, illustrations, formats, logos, hashtags, designs, icons, photographs, software programs, music clips or downloads, video clips, and written and other materials.) Content includes Feedback.
 - When we say “**Feedback**” we mean ideas, concepts, feedback, and know-how that you make available in connection with the Walmart Health Sites.
 - When we say “**make available**”, we mean make available in any way, which includes to post, transmit, upload, distribute, transmit, display, provide, or otherwise submit or make available (including through any part of the Walmart Health Sites administrated by thirdparty social media platforms (e.g., Facebook or Instagram) that allow interaction with the Walmart Health Sites through the tools offered by such social media platforms).
 - When we say “**Materials**” we mean Content that Walmart Health Entities make available on or through the Walmart Health Sites.
 - When we say “**Portal**” we mean the patient portal provided through the Walmart Health Sites.
 - When we say “**Providers**” we mean the healthcare providers that offer or schedule services through the Walmart Health Sites.

2. Your Use of the Walmart Health Sites

You certify that the Content you provide on or through the Walmart Health Sites is accurate and that the information you provide on or through the Walmart Health Sites is complete. You may need to register to use all or part of the Walmart Health Sites. You (not Walmart Health) are solely responsible for maintaining the confidentiality and security of your account including username, password, and any PIN or other unique identifiers. You must promptly notify us of any confidentiality breach or unauthorized use of your user name or password, or your Walmart Health Sites account. Walmart Health is not responsible for any losses arising out of the unauthorized use of your account. You agree that Walmart Health does not have any responsibility if you lose or share access to your device.

Your account may be restricted or terminated for any reason, at our sole discretion. 3. Roles & Eligibility

Walmart Health is independent from the Providers who will be providing services to you through the Walmart Health Sites, and is not responsible for any Provider's acts, omissions or for any content of the communications made by them. Walmart Inc. and the MSO do not engage in the practice of medicine.

If you enter into any other agreement with a Provider regarding a treatment relationship, then these Terms of Use are in addition to the terms of that other agreement. Accessing or using the Walmart Health Site or entering into these Terms of Use does not guarantee that you are eligible to receive treatment from a Provider or obligate any Provider to provide any service to you. General guidelines about eligibility for medical treatment may be made available through the Walmart Health Sites, but the Providers reserve the right, in our sole discretion, to determine whether and to what extent you are eligible to receive any services offered by a Provider. If, in the discretion of a Provider, you are ineligible to receive treatment, the Provider may (but has no obligation to) refer you to a different healthcare provider.

4. Your Use of the Portal

Other than the general informational Materials provided on the Walmart Health Sites, most features and Materials made available through the Walmart Health Sites are provided for the use of patients. You must not use the Portal unless you are a patient, or the legal representative of a patient. You are solely responsible for all activities that occur under your Portal account credentials.

- are either a patient, a patient's legal representative, or have received written approval to access the Portal by a patient via an electronic authorization process approved by Walmart Health;

- have all necessary consents and permissions to view any information with respect to any account that you access, and to undertake any of the actions with respect to any such account that you undertake;

- will maintain the confidentiality and privacy of all information viewed or accessed in any manner through the Portal; and
- will comply in all respects with these Terms and all applicable privacy laws.

5. User and Password Options on Walmart Health Sites

You will be required to establish and maintain an account username and password (i.e. "credentials") to access Walmart Health Sites. You may choose to use Walmart.com credentials to access Walmart Health Sites, or you may choose to establish separate credentials that are unique only to Walmart Health Sites. If you choose to use Walmart.com credentials to access Walmart Health Sites:

- Data collected by Walmart.com will be subject to the Walmart Privacy Policies; and,
- Data collected by Walmart Health Sites will be subject to the Walmart Health Notice of Privacy Practices and associated privacy policies.

6. Your Conduct on the Walmart Health Sites

In connection with the Walmart Health Sites, you will not:

- make available through or in connection with the Walmart Health Sites any materials that are or may be:
 - threatening, harassing, degrading, hateful or intimidating, or otherwise fail to respect the rights and dignity of others;

The arbitrator will conduct hearings, if any, by teleconference or videoconference, rather than by personal appearances, unless the arbitrator determines upon request by you or by us that an in-person hearing is appropriate. Any in-person appearances will be held at a location which is reasonably convenient to both parties with due consideration of their ability to travel and other pertinent circumstances. If the parties are unable to agree on a location, such determination should be made by JAMS or by the arbitrator. The arbitrator's decision will follow the terms of these Terms of Use and will be final and binding. The arbitrator will have authority to award temporary, interim, or permanent injunctive relief or relief providing for specific performance of these Terms of Use, but only to the extent necessary to provide relief warranted by the individual claim before the arbitrator. The award rendered by the arbitrator may be confirmed and enforced in any court having jurisdiction thereof. Notwithstanding any of the foregoing, nothing in these Terms of Use will preclude you from bringing issues to the attention of federal, state, or local agencies and, if the law allows, they can seek relief against us for you.
